

Harnish Wayside dedicated with style

Harnish Wayside was officially opened Saturday, May 24, 2008 with Mayor Leon Sherman and City Administrator Dave Hussell doing the ribbon cutting honors.

Chamber member Helen Harnish Wolgamott gave a brief history of the location. The site, at the corner of Highway 62 and Nick Young Road, was part of her family's farm until Crater Lake (Hwy. 62) cut through it. She grew up on the portion of the farm retained by the family on the west side of the highway.

The Wayside concept came from the Harnish Livery Stable once located in downtown Eagle Point. Grants, savings by the city and a long-term vision by City Administrator Dave Hussell, the city staff and council made a several generation dream a reality.

It is a unique facility. Inside there is an Attractions Room where visitors will find information available about the area. The Little Butte Creek Room provides information about the creek, the watershed and fish and will provide up-to-date water information through a cooperative effort with the Medford Water Commission.

History of the area is evident in the eight large murals painted by artist Ali Pearson. They depict the fish found in the creek, Takelma Indians who once frequented the area, as well as a painting of Avenue of the Flags and major historical scenes, among others.


The Harnish Family donated many items once used in the livery stable.

The park that has been developed along the edge of the creek is magnificent.

It includes a trail to the creek, picnic tables, benches and a BBQ area.

Harnish was planned as a major attraction to Eagle Point with the hope

that people will want to visit the remainder of the community. The center is going to be open Mon-Thurs 10-4pm and Fri-Sun 10-8pm during the summer.
