
Dec. & Jan. meeting hosts

As of Nov. 30, some \$15,000 has been raised in cash and/ or product to be sent overseas. A rather major packing party took place on Dec. 1 and 2 as all the items had to be boxed with a custom forms filled out for each box.

Bryce is the son of Darrin and Claire (Rademacher) Thornton and the nephew of Chamber member, Hank Rademacher.
