Board meeting minutes

The Eagle Point/Upper Rogue Chamber of Commerce Board of Directors met at 7 a.m. Wednesday, Jan. 20 at Moozie's Café. Present were board members President-Bob Pinnell, President-elect Jonathan Bilden, Past President-Sandi Erskine, Budget chair-Dave Pritchett and Secretary-Nancy Leonard. Vice-President was Bob Russell was out of town and Treasurer Hank Rademacher had another appointment.

The meeting opened with a prayer offered by Bob Pinnell. He then congratulated the membership committee, and chair Jonathan Bilden, for the good job in bringing in new members. The membership stood at 120 as of that meeting. He said the Chamber needs to do something special for the committee, but nothing was decided.

It was decided that all of the recent new members, about 50, should receive a welcome letter, a copy of the by-laws, a list of members and a community calendar. Nancy Leonard said the Independent would sell the Chamber for \$3.95 to the Chamber instead of the normal price of \$4.95, thus not donating the \$1 from the sale of each calendar to the Chamber. Pinnell will work on his letter. The board expressed the desire to have the community calendar updated as additional events are added during the year since the calendar is basically printed on demand. Nancy said she would pass that information to her production staff.

There was discussion regarding a concern over the updating of the website. The website committee scheduled a meeting on Jan. 21.

Pinnell said he had reserved the Ashpole Center for Chamber meetings the first Monday of each month in 2010.

Pinnell said he had talked to the Eagle Point City Administrator seeking space for the Clothes Closet. Pinnell said he understood it would be something for the city council to address.

Membership has not been billed for the upcoming year. Dues were due in January. Pinnell and/or Pritchett planned to discuss the billing process with Hank.

Pinnell had asked Nancy to put together costs for advertising. He wanted the price to run a listing of the entire current membership to run in the total market saturation issue. She reported the listing would take 3 columns by 13 inches for a non-profit cost of \$242.50. She also reminded the board that early in the year the board had approved a monthly 3 col x 7 in. ad but there was no agreement on content and it has never been run. After several minutes of discussion a motion was made and unanimously approved to purchase 3x13 ads on the following dates: Jan. 26-listing membership; Apr. 27 promoting 2nd Saturday; May 25 promoting Upper Rogue Yard Sales on June 12; June 29 for Chamber involvement in July 4 and July 27 Promoting Prospect's 60th Timber Carnival. Advertising opportunities with the Chamber

The most important time to advertise is when business is slow. The Chamber has two opportunities that can help keep your business name in front of many. And that opportunity comes by advertising on the Chamber's Website. A vertical ad that is about 2 in. wide by 4 in. deep is \$200 for six months or \$350 for a year. One that is just under 7 inches long and almost an inch in width is \$150 for six months or \$250 for a year. And, for \$75 for six months put your name out there for thousands to see for \$75 for six months and get an ad that is two inches wide x one-half inch in height of \$125 a year. approximate a business card are \$15 while those twice that size are \$30, one time. It is hoped that as we expand, we will also be able to increase the number of pages in the Newsletter. Being safe from fraud

Better to be safe than sorry. Those are some words of advice from Sandi Erskine, Eagle Point PremierWest. With fraud and theft on the increase, she reminds Chamber members that there are some fairly quick and simple steps to take that will be of benefit in an emergency.

She recommends you photo copy your social security number, drivers license, each credit card, insurance cards, and any other information that you would need to report a theft.

If you have collectibles, fine art, personal history on your computer, make sure that information is stored elsewhere. Take pictures of your art, make a list of your collectibles and antiques, take photographs of them if possible. Take this information and put it where only you know where it is. The best place is a safety deposit box.

Attorney General warns of tax preparer scams

Paying taxes can be painful, but falling victim to a fraudulent tax preparer is worse. As tax season approaches, Oregon Attorney General John Kroger is urging taxpayers to watch out for fraudulent tax preparers. Every year, scammers prey on unsuspecting Oregon taxpayers, stealing their refunds and leaving them with significant tax liabilities. The scammers also inflate expenses and claim false deductions and unallowable credits. Oregon is the only state that regulates tax professionals through competency and ethics standards. Anyone who prepares personal income tax returns for compensation in Oregon must be licensed by the Board of Tax Practitioners.

Last year, the Oregon Department of Justice and the Board of Tax Practitioners teamed up to stop an unlicensed tax preparer that violated the law 534 times. Attorney General Kroger and the Oregon Board of Tax Practitioners offer the following tips when choosing an income-tax preparer:

- Check to ensure the preparer is licensed at: <http://www.oregon.gov/cgi-bin/tax.cgi>.
- Never give out personal information such as your Social Security number, bank account or mortgage receipt to a tax preparer unless you have determined they are licensed.
- Be wary of tax preparers who claim they can obtain larger than normal refunds than others.
- Avoid preparers who base their fee on a percentage of your refund.

Tax evasion is a federal felony, punishable by five years imprisonment and a \$250,000 fine. If you or someone you know has fallen victim to a tax preparer scam, contact the Oregon Department of Justice Consumer Hotline at 1-877-877-9392 or the Oregon Board of Tax Practitioners at 503-378-4034.
