

Eagle Point & Upper Rogue Chamber of Commerce Fire Hydrant Decoration Rules



The design should be appropriate for a public space and should not endorse an individual, be political in nature, or be offensive in any way.

Potential design themes include:

- Promoting your business
- Designs by the work of famous artists
- Designs with a whimsical or humorous twist that will make people smile
- Designs that would uniquely connect a particular fire hydrant with its immediate surroundings
- Colorful, abstract designs

The public and private space immediately around the hydrant should be kept clean and neat.

Registration and design approval will begin October 13th 2013. Each hydrant will be adopted for a two year period.

All payments must be made and proposed designs must be submitted the Eagle Point Upper Rogue Chamber for approval.

We have designated specific areas in the city as potential hydrant adoption candidates. They are indicated on the attached map. They include the main entrances to Eagle Point and the business districts.

Applicant must request a specific location first and second choice and be assigned the fire hydrant before starting the design.

Supplies will be provided and are included in the price. Eagle Point Hardware will supply design kit which includes three choices of paint colors, paint brushes, plastic drop cloth and helpful tips.

You must use only the specific paint provided to you by the Chamber/Eagle Point Harware.

Paint only on your assigned hydrant.

You must use paint only. Nothing can be attached to the fire hydrant.

You must stick to the design submitted in your application. If you desire to make changes, you must seek the approval of the Eagle Point Upper Rogue Chamber Fire Hydrant Committee.

If rules are not followed your hydrant will be painted over. The Eagle Point Upper Rogue Chamber will not refund application fee in cases of not adhering to the rules of the program.

Fire hydrants that fall into a state that no longer enhance the immediate area will, after notice will be painted over. For example a hydrant that begins to peel or otherwise deteriorate.
